### Minutes of the Meeting:

The meeting began with a short prayer lead by the President Fr. Paulson Thanikkal. The President and Secretary Extended a warm welcome to each one present and introduced the members. Then a report of activities held in this session was presented in PPT and everybody appreciated the management for the creative work carried on.

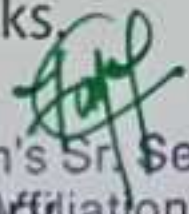
The Secretary Fr. Vincent Damor of SLFC then read proposal of fee which was discussed in the previous meeting held on 16/10/2024. As per Agenda, the budget for the session 2025-26, 2026-27 & 2027-28 together for three years was submitted before the SLFC, by the school management and it was taken up for discussion. The details of the proposed budget along with relevant records and factors were submitted before the SLFC Members.

The members very keenly examined all the relevant factors with regard to infrastructure, qualitative education, various facilities provided as per the web site of the school, education standard, the expenditure on administration and maintenance, salary components, reasonable amount for yearly increments, expenditure incurred on the students over total income of the school, facilities made available for students, reasonable revenue surplus for the school and other factors. Since the budget transparently showed about losses overall, because of reduction the no. of students in the school, the members of SLFC were convinced that fee raise/hike in the coming sessions is absolute necessity and justified. Considering the financial constraints of the parents, **Mr. Bharat Singh Chundawat** suggested that instead of going for hike at one time a step up method could be followed in recovering. If the quality education is desired then the fee has to be increased same year.

All the members present agreed upon the Parent's suggestion and approved the same.

The SLFC members then directed the secretary of SLFC to communicate the details of the fee so approved in writing to the management forthwith.

As there were no other points to discuss, the meeting came to the close with proposing a vote of thanks.
